SFBayCRN Annual Meeting – Session Recordings and CME Now Available!

On September 30th, well over 200 of you joined us for first VIRTUAL Annual Meeting, *Practice-Based Research in a Changing World: Building Capacity to Address the Urgent Needs of Diverse Communities.* The morning session featured keynotes by Dr. Jack Westfall from the Robert Graham Center in Washington DC and by Dr. Hal Collard from the UCSF Clinical and Translational Science Institute, as well as a very engaging panel on research in community-based health systems including many of our bay area partners in the context of the COVID 19 pandemic. The lunch hour included a series of poster sessions highlighting practice-based research partnerships in the SF Bay Area. The afternoon featured a keynote by Dr. Kirsten Bibbins-Domingo on the interaction between structural racism and social determinants of health, followed by a series of presentations on interventions to address social needs at several levels of our health system, and a summation of the day by Dr. Kevin Grumbach.

Participate in the National COVID-19 Primary Care Survey!

Over the last many months, we have encouraged SFBayCRN members to participate in a sentinel network survey organized by the Larry A. Green Center Innovation Network in Richmond, Virginia. This survey has documented critical workforce shortages and inadequate reimbursement related to the burden of the Covid-19 pandemic, as well as increased challenges managing chronic disease, mental health, and social needs of patients. The results have been used to advocate for resources to ensure parity payment for services provided by video and phone at least until a vaccination is widely available. Approximately 5% of responses have come from our network. This week, we have a special opportunity to provide input to the Biden Administration's COVID-19 Task Force. Research Opportunity: Home vs Office for Medication Enhanced Recovery

As you know, opioid use disorder (OUD) continues to be prevalent in many of our communities. Primary care practices are being recruited for a new study called HOMER or *Home vs Office for Medication Enhanced Recovery* comparing office-based, home induction, and observed telehealth methods for medication assisted treatment (MAT) in patients with opioid use disorder (OUD). The AAFP National Research Network is conducting this study to compare different approaches to managing OUD with medication assisted treatment (MAT) in primary care settings, allowing providers, practices, and patients to make an informed choice on the best induction method.
